

LED Integrated Replacement Lamp with Lutron Drivers Limited Warranty for Current powered by GE

Applies to Current LED Tubes operated on Lutron drivers purchased from GE between June 12, 2018 and the date on which this Limited Warranty is later superseded.

Current powered by GE ("GE"), a business of GeneralElectricCompany, is pleased to provide the following limited warranty covering the GE UL Type C LED Tubes for use with the Lutron LED Drivers listed below, when purchased directly from GE from June 12, 2018 until this Limited Warranty document is later superseded. GE warrants that the below-referenced LED tubes, when operated as a system with the Lutron drivers, comply with GE's published specifications and are free from defects in materials and workmanship for the respective periods of time set forth below.

LED TUBE REMEDY: If a GE UL Type C LED tube mentioned below fails due to defects in materials or workmanship within the time periods indicated below, after date of purchase, then GE will provide a credit to the direct purchaser ("Purchaser") equal to the current price GE charges Purchaser for the LED tube. This warranty is based on the maximum annual operating hours stated below and applies only to GE tubes that are operated on Lutron LED drivers that have been properly wired and installed; and operated within the electrical values shown on the driver label.

TERMS AND CONDITIONS: The foregoing LED tube warranty applies only to direct purchases from GE and to tubes and Lutron drivers operated in lighting equipment designed and approved for the application and in environmental conditions (temperature, humidity and air movement) within the normal specified operating range of the system, but does not apply to failures caused by acts of God or as a result of any improper storage or installation, abuse, misuse, abnormal use, or use in violation of any applicable recommendations of GE or any standard, code or instructions for use in installations, including, but not limited to, those contained in the National Electrical Code, the Standards for Safety of Underwriters Laboratory, Inc., Standards for the International Electrotechnical Commission, Standards for the American National Standards Institute or, in Canada, the Canadian Standards Association. GE reserves and has the right to examine failed tubes and/or drivers to determine the cause of failure and patterns of usage. The date of purchase and tube installation date must be marked on the tube or verified to validate the elapsed operating hours if a warranty claim is made. If tube life is not properly validated, the tube date code will be used to establish elapsed burning time based on estimated usage. Any replacement Product will be comparable in function, but may not be identical to the original. The replacement Product is warranted for the remainder of the original warranty period. GE is not responsible for any labor or other costs associated with removal or reinstallation.

THE FOREGOING WARRANTIES CONSTITUTE THE SOLE AND EXCLUSIVE REMEDIES OF PURCHASER AND THE SOLE LIABILITY OF GE FOR CLAIMS BASED ON DEFECT IN OR FAILURE OF PRODUCTS, WHETHER THE CLAIM IS IN CONTRACT, INDEMNITY, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE. THESE WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER WRITTEN, ORAL, IMPLIED OR STATUTORY. NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS MADE OR IS TO BE IMPLIED. IN NO EVENT SHALL GE BE LIABLE FOR ANY OTHER COSTS OR DAMAGES INCLUDING LOST PROFITS, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES.

TO MAKE A WARRANTY CLAIM: To make a warranty claim, retain the failed products and notify your GE sales representative in writing within thirty (30) days of the failure. This warranty extends only to Purchaser. However, GE will honor, under the terms of this Limited Warranty, valid warranty claims made by Purchaser for the remedy set forth above as a result of warranty claims made to Purchaser by its customers and indirect customers.
