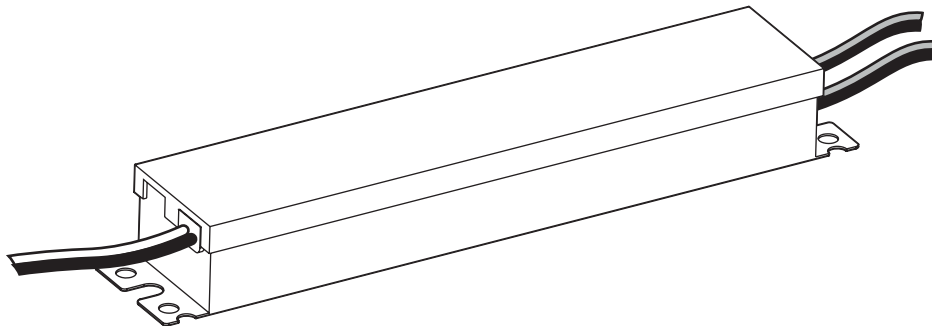

## Prepare Electrical Wiring



### Electrical Requirements

- The LED driver must be supplied with 100-277 VAC, 50/60 Hz and connected to an individual properly grounded branch circuit, protected by a 15 or 20 ampere circuit breaker.



### Grounding Instructions

- The grounding and bonding of the overall system shall be done in accordance with National Electric Code (NEC) Article 600 and local codes.

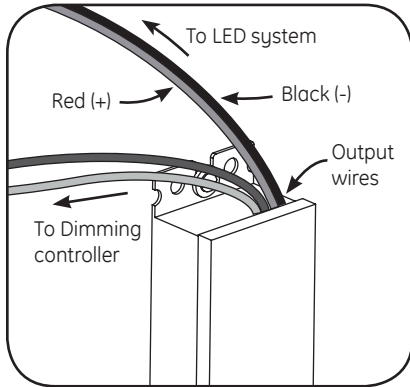

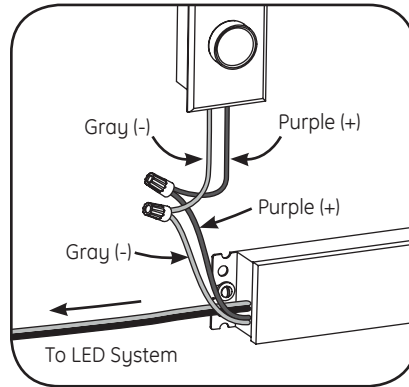

## LED Driver Installation

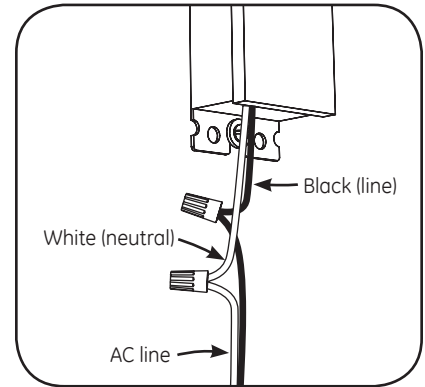


- 1 Connect the supply wire that is attached to your LED system to the red (+) and black (-) output wires of the LED driver as outlined in the **“Electrical Connections”** section of your LED system’s **Installation Instructions**.

To ensure the LED driver load and remote mounting distances are within the ranges specified in the product installation guide.



- 2 Connect the (+) purple and (-) gray wires of the LED Driver to the 0-10V dimming controller. Refer to the dimming controller installation instructions for specific connection information.



- 3 Connect the AC line to the black (line) and white (neutral) input wires of the LED driver using 18-14 AWG (0.82-2.08 mm<sup>2</sup>) UL approved wire connectors. Properly ground power supply in accordance with National Electric Code (NEC) Article 600.
